We are pleased to share Positive Resource Center's (PRC's) 2012 annual report with you. Last year marked our 25th anniversary of service. Thanks to you, for a quarter of a century we have been able to help people affected by HIV/AIDS or mental health conditions overcome their financial and healthcare challenges. We can all take pride as we reflect on the difference we've made together in the lives of so many individuals.

We are proud that in the last five years alone, our Benefits Counseling attorneys have won over \$25 million in retroactive disability payments for our clients and have secured health insurance for over 3,000 previously uninsured individuals with chronic health conditions. Our Employment Services staff have helped over 1,600 disabled workers find employment in such industries as biotech, healthcare, hospitality, IT, retail, and social services, enjoying average earnings approximately double the San Francisco minimum wage.

In this report, you will see how our clients have been able to succeed in ways they had not imagined possible. Thousands have moved from homelessness to stable housing, from lacking healthcare coverage to securing health insurance and access to medical care, and from unemployment to finding work in a most difficult job market.

We at PRC always remember that none of our work would be possible without your great generosity and commitment to ensuring that San Franciscans living with HIV or mental health conditions have access to the financial and healthcare resources we all need to thrive. Together we are making a real impact on people's lives!





Benefits Counseling Program

In 2012, 1,238 women and men turned to PRC because they had become too disabled to work as a result of their HIV/AIDS or mental health conditions and required assistance with securing public benefits to provide them with regular income and healthcare coverage. With disability benefits such as Supplemental Security Income (SSI), Social Security Disability Insurance (SSDI), Medicare, and Medi-Cal, these individuals were able to afford the stable housing, nutritious food, and routine medical care needed to help them stabilize their lives.

PRC's Benefits Counseling Program's attorneys are experts in Social Security law and represent clients throughout the complicated administrative process of accessing disability benefits, winning over 90% of fully adjudicated Social Security claims. "I have been going through so much mental and physical pain for so many years. I was very scared and did not know how to get help. PRC was on top of everything and I was approved for SSI and SSDI on my first try. Thank you!"

Employment Services Program

PRC's Employment Services Program offers a full spectrum of vocational rehabilitation and employment placement services to support our clients in entering or re-entering the workforce. Our services focus on the unique issues people with disabling HIV or mental illness face, from fear of discrimination in the work place to maintaining their health, medical appointments, and medication adherence while working, managing stress, maintaining housing, or keeping benefits while they are employed.

Through our Employment Services Program in 2012, 415 individuals—from the newly unemployed to those who have been unemployed for many years due to disability—explored their work options, accessed computer training courses, and received job placement assistance. "PRC has been of great help in my search for new employment opportunities. I am most satisfied with the outcome of my new resume. Their professional experience and advice really helped during the process. I also enjoyed the workshops on interviewing and the Job Club, lots of great information. I plan to make full use of the excellent services and hope to soon be employed."








Client Demographics
