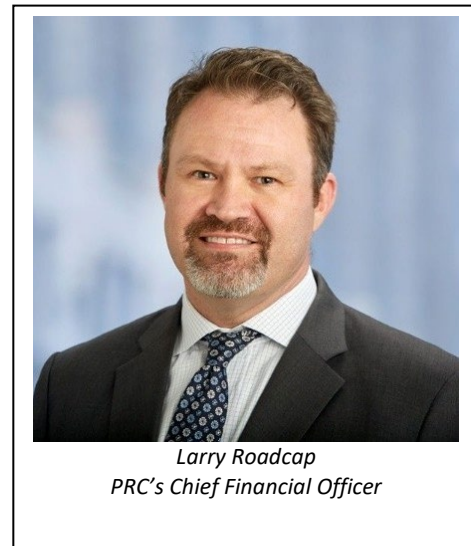


PRC Names Larry Roadcap as Chief Financial Officer

SAN FRANCISCO (August 12, 2022) – [PRC](#), the San Francisco social impact nonprofit that elevates the lives of those affected by poverty, HIV/AIDS, substance use disorder or mental illness, announced Larry Roadcap as its new chief financial officer. Roadcap started work with PRC on August 8, 2022.

In this role, Roadcap will oversee and administer PRC’s financial accounting, budgeting and planning, government contracting and compliance processes, as well as manage critical relationships with City of San Francisco oversight agencies.

Roadcap’s professional experience encompasses nearly two decades in the nonprofit and corporate sectors. His global experience as a finance and risk management executive with extensive experience implementing IT systems to improve financial controls, regulatory compliance, accounting, tax, and financial reporting functions will advantage PRC. Most recently Roadcap served as interim chief financial officer for Charles E. Smith Jewish Day School in Rockville, MD, where he managed a \$30M operating budget (890 students, 300 employees) and a \$42M endowment.
