PRC Appoints Chuan Teng as Chief Executive Officer

SAN FRANCISCO (January 20, 2023) – [PRC](#), the San Francisco nonprofit that offers comprehensive and relevant services for individuals living with HIV/AIDS, substance use disorder or mental illness, today announced Chuan Teng as its new chief executive officer.

In this role, Chuan assumes overall accountability and responsibility for the management of the organization and the executive leadership team, in accordance with the strategic and sustainability plans adopted and approved by the board of directors. Teng will also ensure and oversee PRC's legal compliance, financing and governance of the board of directors.

Most recently, Chuan served as PRC's interim chief executive officer, and has worked for PRC for eleven years, starting as a staff attorney helping clients access public benefits. During her tenure, she served as the managing legal director of PRC's Legal Advocacy Program, where she helped launch its healthcare legal services practice, then as the chief of programs and confidentiality officer, and then as chief of client services and talent.

She conducted and developed results-based accountability trainings and focused her work on helping cities implement effective enrollment strategies to deliver results. Chuan holds a bachelor's degree from the University of Michigan, Ann Arbor and a juris doctor degree from Santa Clara University. She is a licensed attorney in California and a mom to a two-year old who loves to chat and sing.
